

## ELIGIBILITY:

**The art competition is open to residents of Colorado.** Only original artwork conceived and created by the entrant will be considered. "Original" also means if artwork is based on reference photos, the photos were taken by the artist or were used with permission of the photographer.

All artwork must include all parts of one **11"x14"x½" stretched canvas**, either in its original form or deconstructed and reassembled in another form, as long as **all** parts of said canvas including staples and stretcher bars are included in a single piece of art either internally as an armature or surface for an artwork or as the artwork itself. Sculpture, photography, and other mediums will be considered. Work done in photography, including any use of photographs or photocopies other than as elements of a collage, will only be considered if a specified 11"x14"x½" stretched canvas is an integral part of the piece.

All artwork must depict the theme of "**SEEING THE WORLD ANOTHER WAY**", in honor of our guest speaker, Dr. Temple Grandin. All participating artists are encouraged to stretch beyond previous perceived limits and comfort to embrace new ways of expressing their creativity by taking a new look at the world from another point of view. **Non-compliant pieces will be disqualified.**

## PREPARING YOUR ENTRY:

You may enter up to 2 pieces for each **\$40.00** fee. All entries require advance photograph submission for judging. All entries must be accompanied by a completed entry form that provides the title, medium (oil, watercolor, etc.), dimensions of piece along with a separate typed sheet with brief description of how each work represents the theme of

*Optionally, artist may also include brief artist biography. (100 words or less each).* The titles of the images on the CD must match the titles on the sheet. **Pieces with incomplete entry forms, information sheets, or descriptions will be disqualified.**

All image files must be in JPEG format and cannot exceed 2MB. The file must be in RGB color mode (not CMYK). Images cannot exceed a height or width greater than 800 pixels. No slides or prints will be accepted.

**Fees and Payment:** Entry fee is \$40 for up to two art submissions. A check or money order payable to "Colorado Women's Education Foundation" for the total required jury fee (in U.S. funds, drawn on a U.S. bank) must accompany your submission. There will be a \$10 charge for all returned checks. Entry fee may also be paid online. See entry form for details.

Materials submitted via regular mail will not be returned. CWEF will not be responsible for the loss, damage, or return of any submissions for the competition. Disqualified entries will not receive a refund.

### DEADLINE:

Entries must be postmarked no later than **March 15, 2011.** E-mail submissions must be received by midnight (MST), March 15, 2011.

### JUDGING:

Entries will be judged in advance to determine eligibility for inclusion in the *Legacy of*

*Learning* art auction on **April 11, 2011.** The fundraising event's purpose is to share the mission and garner support for the non-profit organization, *Colorado Women's Education Foundation.* The event will be held at the Gatehouse at Lionsgate Center in Lafayette, CO and will be attended by approximately 200 people who have paid \$125 per ticket. Artists are welcome to buy tickets to attend the event. For more information, go to [www.cwef.org](http://www.cwef.org).

The finalists will be chosen by the CWEF Board of Trustees and qualified judge(s) appointed by CWEF. Selected pieces will be auctioned in either a silent or live auction at the CWEF *Legacy of Learning* event. 50% of the proceeds of the sale of each piece sold at the event will be paid to the artist of said piece within 45 days of said event. The other 50% will benefit CWEF.

**The Finalists will be notified where and when their original art work should be delivered.** The decision of the jurors is final. All sales are final, and artists may not set reserve prices.

If no bids are received on a piece, that piece will be available to be retrieved by the artist at a time, date, and location to be announced. CWEF will not be responsible for any pieces not retrieved by the specified deadline, and those pieces will become the sole property of CWEF.

### NOTIFICATION:

All finalists selected for the auction will be notified via phone or e-mail by **March 30, 2011.** Entrants not selected for the auction will not be individually notified of the results. Your cancelled check will be notification of receipt of your entry.

You may also include a brief artist biography (100 words or less). The artist biography is not required. Save digital images of each art submission on a CD, flash drive or e-mail. Images cannot exceed a height or width greater than 800 pixels. No slides or prints will be accepted.

### Deadlines and Notification:

All entries must be submitted no later than March 15, 2011. Winners will be notified by phone or e-mail on or before March 30, 2011. Non-winning entrants will not be individually notified of the results. Your cancelled check will be notification of receipt of your entry.
